Terms & Conditions

These General Terms and Conditions (hereinafter: GTC) define the conditions for the use of services between the Parking Office of the Municipality of Hévíz (hereinafter: Parking Office) and the natural person using the Season Ticket or Day Ticket Buyers (hereinafter referred to as the Customer), hereinafter together as the Contracting Parties, as well as the rights and obligations arising between the Parking Office and the Customer.

Concepts:

Virtual Pass and Parking Permit Seller: Parking Office. Customer: Persons purchasing day tickets, season tickets, parking permits.

The obligation to pay the parking fee must be fulfilled as defined in Municipal Decree No. 25/2020 (VII.20) of the Municipal Council of the City of Hévíz on the order of waiting for vehicles in the public areas of the city of Hévíz.

When buying a day ticket (or season ticket), we do not take any responsibility for passenger cars, our parking spaces are not guarded.

This agreement stipulates that the personal data necessary for the management of the pay parking (surcharge): name, address, registration number will be stored on the website during the period of validity of the ticket or pass.

The concluded contract does not qualify as a written contract and is therefore not available in filed form. The conclusion of the contract is confirmed by the purchase data saved electronically. The agreement between the Parties shall be concluded in the language chosen and, in the event of a dispute, in Hungarian.

The Parking Office issuing the season ticket / parking permit informs the Customer and the Customer expressly acknowledges that the Parking Office is entitled to unilaterally amend the GTC. In the event of an amendment to the GTC, the Parking Office shall notify the Customer by publishing the changes www.onkormanyzat.heviz.hu, before the amendment enters into force.

The validity of the parking ticket on the day specified at the time of ticket purchase is valid for a period corresponding to the purchased consideration in accordance with municipal decree 25/2020 (VII.20). In the case of a pass, the pass is valid until 31 January following the current year. All passes and parking tickets are valid for a registration number. It is possible to buy and exchange a season ticket only at the customer service office.

In connection with the processing and storage of personal data, the Parking Office acts with the utmost care that can be expected. However, the Parking Office shall not be liable for any damage caused by unavoidable attacks that take place despite the utmost care.

With this information, the Customer informs the Customer that by purchasing a season ticket / applying for a parking permit, his personal data will be stored in accordance with Act CXII of 2011 on informational self-determination and freedom of information (hereinafter: Privacy Act). He processes, processes and transmits his personal data specified in Section 3.2 for the purpose of operating the rental / parking permit, identifying the Customer, fulfilling the related rights and obligations. Data processing is based on voluntary consent, which is activated by providing the data.
