

## DECLARATION ON THE USE OF THE CENTRAL SAFE

1. I acknowledge placing my items in the safety box of Tisia Hotel & Spa, being informed that access to the safety deposit box will only be granted upon presentation by me in person of the above-mentioned key, the receipt of which I confirm by my below signature on the present document of proof.
2. The Hotel shall not be liable for any losses that may occur if the above conditions are not fulfilled.
3. The Hotel is authorized to force entry to the above deposit box number and remove all items from it if I don't return the key at check out before I depart from the Hotel.
4. In case the conditions of clause 3 enter into force, the Hotel shall not be liable for any losses that may occur as a consequence hereof, nor while the items removed from the safe are in the Hotel's custody.
5. If the key to the safe is lost while in my custody or if I can't give it back in usable condition for any reason at checkout, I shall pay the Hotel the amount of 100.000 HUF to cover the costs for opening the safety deposit box and replacing the key.
6. The Hotel is responsible for the security of the safe and access to it, as adequate considering its location, and the Hotel assumes responsibility for losses due to fault or negligence of the Hotel only up to a maximum amount equivalent to the lesser of 50 times the daily room rate. Besides this, the hotel is responsible under local law for the contents of each deposit box. The hotel is not responsible for any damage caused by changes due to the nature of the item deposited in the safe or properties that require special treatment.
7. The safe may be used for the storage and safekeeping of valuables, documents, and other personal belongings. Cash and securities may be placed in the safe only after they have been counted in the presence of the competent employee of the Hotel and/or the amount has been fixed.
8. Compliance with the above prohibitions may be checked by the Hotel at any time in the presence of the Guest, in particular in the absence of a justified case, by viewing the contents of the safe. The Guest is liable for damages and costs arising from noncompliance with the prohibitions.

### The safe cannot hold:

- weapons, ammunition, chemicals, living beings
- any substance, which is flammable, explosive, toxic, radiant, fissile, corrosive, perishable, flammable, emits an unpleasant odor, has a sound effect, or is harmful to health or the environment;
- substance or thing capable of spontaneous combustion or causing fire or explosion;
- valuables and devices requiring continuous maintenance and preservation;
- material, devices that monitor, disturb, or damage the electronic and other systems operating in the Hotel;
- anything that endangers the safety of the Hotel building or its employees;
- something the possession of which is prohibited, punished, or restricted by law;
- something that could make other items in your safe compartment unusable or diminish their value

The Hotel may check compliance with the above prohibitions at any time by inspecting the contents of the safe deposit box in the presence of the Guest, or particularly justified cases without the Guest being present. The Guest shall be liable for any damages and costs incurred as a result of noncompliance.
